




Peer review **KEY FEATURES**

Costs covered by the platform:

- For hosts:
 - Catering, interpretation and local transport (if needed)

 - Travel and accommodation costs
 - Flat Daily Allowance (FDA) of EUR 350 for up to three working days (upon request per organisation)
